




# **Buz® Point** G 502

Highly effective universal stain remover for textile coverings and surfaces





## Area of application

• For stain removal on solvent-resistant, colourfast surfaces, carpets and upholstered furniture

### **Product properties**

- Problem solver with very high effectiveness and dirt dissolving power
- Removes water-insoluble soiling such as rubber abrasion, chewing gum, paint, oil and grease, tar and bitumen, resin and lubricating oil stains, shoe polish, copy and stamp ink, ballpoint pens and felt-tip pens, ink and wax
- Effortlessly removes even stubborn adhesive residue from stickers and lahels
- Leaves no residue
- Stain-removing power based on natural raw materials
- Economical consumption due to high area coverage with spray attachment
- Leaves a characteristic fruity orange scent

## **Application and dosage**

- Spray the stain on solvent- and colour-resistant textile coverings, let it briefly take effect, blot it away from the outside to the inside with a clean rag, remove it with a spatula if necessary.
- Consumption: 0,1 0,2 ml / per application



### **Note**

- Before use, test for material compatibility and colorfastness on an inconspicuous area.
- Do not use on polystyrene.
- The product must be used up within 6 months after first use, otherwise technical problems cannot be ruled out.
- Observe the manufacturer's cleaning instructions.
- Changes or variations in colour of the product do not impact on the quality. The product image may differ in colour and shape from the original.

- Storage: Always keep containers closed. Store at room temperature in the original container. Consume opened containers within 9 months.
